- 1. Thanks & Welcome!
  - Kelly G. shared some delayed thank-yous from staff from Christmas gifts
  - Kay thanked Peter W. and Matt K. for coordinating weekend Masses for Catholic Schools Week
  - Carrie M. thanked Kay and the teachers for the letters that came home with the students during Catholic Schools Week
  - Blaire M. thanked Justin for signage coordination
  - Heather M. thanked Danielle B. for taking care of getting supplies for Catholic Schools Week
  - Kim Desotell thanked SAC members for their support of Catholic Education and Resurrection Parish for new doors at school
- 2. Open Forum
  - o None
- 3. Approval January Minutes Bridget E./Blaire M.
  - Motion to approve minutes Matt D.; second Justin D.; Motion carries.

# 4. Principal's Report - Kay F.

- Kay shared the results of the Voice of the Customer report; 71 families responded out of 178 families at our school; results were very favorable
- o It was suggested that the results be broken down between elementary and middle school; Kay thought that could be completed by next month's meeting
- Kay passed around a follow-up questionnaire for SAC members to complete after reviewing the survey results; SAC members are asked to review and complete before next month's meeting
- Kay shared the Lenten plans at both schools; Middle school students will get booklets with daily reflection and journaling opportunities, and 15 minutes of each school day will be devoted to the reflection
- Carrie M. asked about middle school service requirements; Kay said that it is 5 hours per trimester starting second trimester; Kay said that Deacon Dan is to circulate forms, but she will also post on Google Drive
- Kay shared that some social media activity that is being circulated outside of school has affected school
  interactions; Kay had a conversation with certain classes about expectations and impacts of actions; Kay
  was clear with students that if these things happen there will be consequences
- There was a suggestion that social media policies and consequences be incorporated into the school handbook
- Enrollment for next year is presently around 200 students; Kay's goal is 300 students; this year's enrollment is presently just shy of 300 students

## 5. Financial & SCRIP Report – Steve

- Awaiting financial updates from GRACE

### 6. Old Business

- Res Entrance Updates Kim Desotell
  - i. GRACE is unique in that all facilities are owned by parishes; poses a unique circumstance when addressing facility updates
  - ii. It's important to give time and attention to facilities
  - iii. Any improvements or modifications need to go through Parish's Building & Grounds Committee
  - iv. Kim shared that the front entrance is ripe for safety and aesthetic update (air lock); other potential update opportunities: outside main entrance overhang, signage, landscaping, overhang at gym entrance
  - v. St. Matt's site five turns are required to get into the office once you get into the building; a better setup may include a reception counter at the entrance
  - vi. Suggested a SAC Buildings & Grounds Committee that begins to build out some priorities for building needs and improvements; 3-year plan to do specific upgrades
  - vii. Plans would be an investment but would provide clear budget and planning
  - viii. GRACE 2022-2023 budget includes grant funds to provide an opportunity for parishes and schools to apply for facility funds; funds are available to assist with projects and design costs; fund sunsets on July 1; there have only been two applications received to date; applications are for \$5000-10,000 to date; application requires signature of pastor and principal
  - ix. Kim offered to have a member of GRACE's facility team to sit on the committee and help as well
  - x. If we don't have a 3-year plan, then the worry is about where we are at in 3 years and 3 years after that
  - xi. Applications are being given priority for safety; applications that propose matching funds are more attractive to the approval committee
  - xii. Fr. Tom inquired about new lockers; Kim thought that would be a doable project
  - xiii. GRACE Finance Chair is Marv Wall; he is now facility manager at Mulva Cultural Center; would be a great person to bring in to a project like this

- xiv. Heather M. asked if we can apply for additional federal and state grants on behalf of our school; Kim said it is very doable, but there can be a lot of red-tape that comes along with that
- xv. Architect and construction company could collectively be enlisted to prepare a comprehensive plan
- xvi. It was suggested that committee may be comprised of non-SAC members, both school parents and parishioners, that have knowledge in these areas
  - 1. Discussion ensued as to what this committee looks like; teacher from each campus; representative of each parish; Kay; GRACE representatives
  - 2. It was collectively agreed that the first step is to build a well-thought out committee; Kelly will put together an announcement in the newsletter to see if there are any school families that are willing to step up to spearhead this committee; SAC members will also give some thought to community members that might have some insight or knowledge as well
- Campus FAC sign (Res)
  - i. Proposal has been sent by Creative Signs; it is being circulated and will be signed by Kay and Kelly
- Teacher's lounge updates
  - i. Kay is looking for someone to spearhead to teacher's lounge updates; Matt Dufek said that his wife, Pam, would assist with coming up with a plan with for the design and layout for the room (plumbing, flooring, electrical)
- o After school clubs/extracurriculars survey needed
  - i. Kay circulated a list of ideas for enrichment opportunities for elementary students; there is potential Title IX funding
  - ii. Discussion ensued; next steps/priorities:
    - 1. Do you have a passion? Will you share it with others? A future newsletter call out with pose these questions to school families
    - 2. Kay to poll teachers would they be willing to spearhead some of these after school activities?
- o Mid-year check-in
  - i. Kay would like to offer a mid-year check-in for new families; timing is an issue since spring break is coming up
  - ii. Suggestion was to shift focus this year to mid-year check-in via email or written communication because of timing; next year SAC will look to hold mid-year in-person event

#### 7. New Business

- SAC Hilltop Hoedown donation expenses
  - i. There was a donation from SAC for "something special"; Kelly G. shared that Mrs. Ellis has a side cookie-making business; cookies for all students will be ordered from Mrs. Ellis at an SAC expense to fulfill this donation
- 2023 fundraiser date & commitments
  - i. SAC has been advised that two other GRACE schools intend to hold their major fundraising events the same night that we have historically held our event
  - ii. Kim D. was asked if there was a problem with that or if we can proceed with holding the event the same weekend as we have in the past
  - iii. Kim D. shared that multiple events around the same time may be challenging for vendors that we tap and for shared fundraising software, but acknowledged that there isn't a lot of overlap between attendance of the events
  - iv. Kim D. said GRACE wouldn't stop or prohibit us from having event on preferred night even if other schools are having their fundraising event the same night
- o FACS alumni feature
  - i. Kay intends to spearhead recurring feature in the newsletter, website or Facebook that will spotlight alumni; it was suggested that social media posts be limited

  - i. 8<sup>th</sup> grade will be doing chili cookoff event to raise funds for graduation
- o Activities and Community Outreach Danielle, Heather, Magy and Kerry K.
  - i. Cookies, cocoa and cards event held recently and was successful
  - ii. Open gym events have been well received
  - iii. There will be a childcare "open play" held at conferences at elementary school; volunteers needed
  - iv. Other upcoming events are being planned
  - v. Discussion ensued regarding SAC's involvement in Field Day and special persons' day

  - i. Peter W. and Matt K. are planning to cover a Lenten theme each week in the newsletter with the idea that a different family would be featured each week and share how they incorporate that theme into their family

  - i. February 28<sup>th</sup> teachers will receive dinner (in-person conferences)
  - ii. May 12<sup>th</sup> is an early release day; if it is a school in-service, committee would plan an off-site luncheon for teachers
  - iii. Admin assistant day is coming up; working on gifts for that and principal's day, which is kickoff to teachers' week
