 - 3. St Matt Will get check in July
 - 4. Our check will be last
- \$10K in pending expenses
- June will be new budget review month....July will be the vote

6. Principal's Report - Francis

- Staffing Update
 - i. Contracts were due at 3pm today
 - 1. 4 that will not be returning
 - More information to come
 - ii. Contracts are reviewed as part of the observation process; if teacher is not meeting requirements, they can be placed on an improvement or the contract will not be renewed
 - iii. Discussion around the incentivizing of teachers and salary. Ideas discussed but more to come based on GRACE and their feasibility study
- o Enrollment Update
 - i. 288 Current Enrollment for next year (308 with those pending)
 - 1. Up by 35 in comparison to last year at this time
 - 2. 4th highest enrollment in GRACE schools
 - 3. People are moving here because they appreciate the family look and feel
 - 4. 40+ in 4K
 - 5. 2 Sections will be needed next year in:
 - 4k, 5k, 2nd, 3rd, 4th
 - 6. If the enrollment keeps growing, we wouldn't have enough rooms, for current staffing needs but there is time figure out the problem
